### FAMILY SOLUTIONS PROGRAM OUTCOMES IN ATHENS CLARKE CO GA

During the years 2007-2010 there were 137 juvenile first offenders who appeared in the Athens/Clarke County Juvenile Court/Department of Juvenile Justice who were referred to the Family Solutions Program. First offenses include truancy and school code violations of legal implications. Among these youth, 105 completed the 10 session Family Solutions Program, or 77% of all youth referred. The re-offense rate for the 105 youth who completed the program was 24%. This percentage of re-offense for FSP graduates has been consistent since 1993. The re-offense rate for the 22 who did not complete the Family Solutions Program was 36%. In addition, both male and female FSP graduates had lower reoffense rates than male and female FSP non-graduates. This difference was particularly striking for males. Thus, the impact of the Family Solutions Program can be evidenced by the lower re-offense rate for those youth who complete the program as compared to juvenile first offenders who do not attend or complete the Family Solutions Program. Some of these juvenile first offenders who completed the Family Solutions Program successfully were originally referred due to school attendance or behavior violations. Thus, the FSP is effective for school-based problems.\*

#### The Family Solutions Program helped my family's problems:

Youth ID 2621: "I learned that age has no limit on learning. If you believe it you can achieve it. I will continue to believe that I can be anything I want to."

Youth ID 2620: "Families4Change has changed the way I respond to all of my family and the way I'm going to have my future. I want to go to college because I want to get paid good money and have more education for when I get older."

Youth ID 2542: "Family Solutions has helped me get along better with my parents and understand that my parents are right about most things."

Youth from Clarke Central: "Family Solutions has benefited me and my mom. It helped us have better communication and good reflective listening to avoid conflict and to effectively resolve disputes."

Youth ID 2543: "Another way it (FSP) helped was that we could look at other families' problems and realize that we aren't the only family with problems. I liked communication because it was the session that we needed to hear the most."

Parent ID 2626: "Family Solutions has helped me and my daughter a lot. Before, we didn't hear each other when we argued, but now we listen and try to avoid from hollering. I would do FSP again and volunteer in other groups. Thank you."

#### Would you recommend this program to other parents/youth?


Parent ID 2622: "I have learned a lot from this program. I thank you for letting me and my child be a part of the program. I will continue to apply it to my everyday life."
